


Internet Fraud

Internet Fraud The Internet Crime Complaint Center (IC3) (www.ic3.gov) recently ranked Internet Computer Fraud as the fifth highest reported crime. The IC3 reminds consumers of the need to be extremely vigilant when giving out personal information to unverified sites.

Five Prevention Tips for home computer users:

- 1) Ensure your operating system includes firewall protection.
- 2) Install, run, and maintain updated anti-spyware software.
- 3) Ensure that all web-sites used for accessing account information or shopping is secure.
- 4) Avoid downloading programs from unknown sources.
- 5) Log off completely and close your browser after logging off from secure Web sites.

NCUA Insurance Increase Extended Through 2013

On May 20, 2009, Congress enacted "Helping Families Save their Homes Act of 2009." This act extended the temporary increase in the NCUA's standard maximum share insurance amount from \$100,000 to \$250,000 on your regular shares, share drafts, money markets account and share certificates. 27 Years of Service

The Board of Directors regretfully accepted the resignation of William "Bill" McAllister at their May meeting.

Bill began his teaching and coaching career at Derby High School in 1963. He held the positions of assistant and head coach of the Derby High School football team for five years.

In 1968, Bill returned to his alma mater Ansonia High School, as a teacher and the head coach of the football varsity team. During his 35 year coaching career at Ansonia, the team won six NVL Championships, 6 State Championships and held a winning record of 130-36-2.

In 1983, Bill retired from coaching the Ansonia High School Football team when he was named principal of Ansonia High School. However, his love for football further led him to coach the Yale University Freshman Football team for three seasons.

Bill has been a member of the credit union for over 38 years. He served the membership as a volunteer director for 27 years, and he also held the office of Treasurer from 1987 – 2008. Throughout the years he volunteered for various committees of the board including the Nominating and Scholarship committees. His thoughtful and faithful leadership and guidance will be missed by the directors and management. Bill has made a lasting impact and we wish him well in his retirement and thank him for his service.

Wepawaug-Flagg Federal Credit Union strongly believes that confidentially and protections of member information are among our fundamental responsibilities. We are committed to maintain confidentiality as we serve you, our members.

TYPES OF INFORMATION WE COLLECT

In order to conduct business with you, we collect nonpublic personal information about you from various sources: Information we receive from you on applications and other forms, such as your name, address and social security number. Information about your transactions with us or other forms, such as your account balance, payment history and credit card usage. Information we receive from a consumer reporting agency, such as your credit worthiness and credit history.

TYPES OF INFORMATION WE DISCLOSE

In order to provide you with products and services to meet your financial needs, we may disclose information as permitted by law. If you discontinue your relationship with Wepawaug, we will continue to comply with this privacy policy and protect the nonpublic information we have collected from or about you in accordance with the law.

OUR SECURITY MEASURES

Wepawaug-Flagg restrict access to nonpublic information about you to those employees who need to know that information to provide products or services to you or who may be responsible to maintain information security practices. We also maintain physical, electronic and procedural safeguards that comply with federal regulations to guard you nonpublic personal information.
